4.108年6月14日修正發布專門職業及技術人員高等考試技師考試規則，有關全部科目免試規定，改為部分科目免試，並訂定落日條款，符合資格者得於111年12月31日前申請，逾期不受理。

Note :

1. On December 11, 2018, amendments to the regulations for the Senior Professional and Technical Examinations for Medical Personnel (including medical technologists, medical radiation technologists, registered professional nurses, physical therapists, occupational therapists, registered professional midwives), as well as for Dietitians, Psychologists, Speech Therapists, and Veterinarians, were promulgated. The provision for full subject exemption was limited to a three-year period and scheduled for discontinuation. Eligible individuals could apply by December 31, 2021.
2. On January 14, 2019, amendments to the Senior Professional and Technical Examinations Regulations for Architects were promulgated. The provision for full subject exemption was revised to partial subject exemption, and a sunset clause was introduced. Eligible individuals could apply by December 31, 2022; late applications would not be accepted.
3. On April 22, 2019, amendments to the Junior Professional and Technical Examinations Regulations for Land Administration Agents were promulgated. The provision for full subject exemption was revised to partial subject exemption, and a sunset clause was introduced. Eligible individuals could apply by April 24, 2022; late applications would not be accepted.
4. On June 14, 2019, amendments to the Senior Professional and Technical Examinations Regulations for Engineers were promulgated. The provision for full subject exemption was revised to partial subject exemption, and a sunset clause was introduced. Eligible individuals could apply by December 31, 2022; late applications would not be accepted.
